Description:

A specially formulated cleaner to revive weathered and tired hardwood and softwood timber decking.

Benefits:

- ◆ *Fast acting formula.*
- ◆ *Revives weathered decking.*
- ◆ *Removes organic growth.*
- ◆ *Prepares decking prior to surface treatments.*
- ◆ *Suitable for hardwood and softwood deck boards.*

Uses

Removes dirt and natural deposits from decking, restoring the wood back to its natural appearance. Should be used prior to treating decking boards with stains and oils as it provides a good key and long lasting finish.

Preparation

Always test on a small inconspicuous area before use to ensure you get the desired result. Remove debris and accumulations of organic moss, mould and algae using a stiff brush.

Application

1. Pour decking cleaner directly onto the deck surface.
2. Scrub the surface immediately using a stiff brush then leave for 15-20 minutes.
3. For best results thoroughly wash with a pressure washer. Work from one end of the decking board to the other in a continuous motion. Alternatively scrub the surface using a stiff brush then hose down. All cleaning residues must be completely washed away to maximise the performance of the following coatings.

Note: DECKING CLEANER is not recommended for use on composite decking, please use Patio Blaster instead.

Clean Up

The surface may become slippery during cleaning. If DECKING CLEANER comes into contact with plants or grass, rinse thoroughly with water. Do not allow undiluted product to enter drains or watercourses.



Coverage

5 litres will cover approx. 20m² of decking.

Container Size

5L plastic bottle.

Colour

Clear liquid.

Shelf Life

24 months from date of manufacture when stored in original sealed containers.

Storage Conditions

Store in cool, dry conditions in original sealed container between 5 and 30°C. Protect from frost.

Disposal of Containers

Do not leave empty containers where residue could be harmful to children, animals or the environment. Replace lids and remove any containers to a central disposal point in accordance with local regulations.

Health & Safety

Please refer to separate material safety data sheet for full handling, use and storage instructions. Keep out of reach of children. It is the users responsibility to determine suitability for use. If in doubt contact our Technical Department for advice.

Note: this information is for general guidance only, since site conditions and labour are beyond our control. It is recommended that users make their own tests to determine suitability.
